#### **Course description**

Calculus-based introduction to statistical data analysis. Includes sampling, experimental design, probability, binomial and normal distributions, sampling distributions, inference, regression, ANOVA, two-way tables. The prerequisite for this 3 credit hour course is differential calculus.

- To enable you to understand the use of sampling distributions as the foundation of inference.
- To enable you to analyze data through linear regression, confidence intervals, and hypothesis tests.
- To enable you to use your knowledge of calculus to conceptually understand its role in computing probabilities.

#### **Recitations**

You will be put in groups of 4-5 people. During the recitation, you will work with your group in a breakout room on the recitation activity. Those students that are present during the recitation will be able to submit one recitation activity as a group and will all receive the same score. The recitations will be graded out of 4 points based on both completion and accuracy. If anyone is absent during the recitation they must submit the activity on their own. They can get help from their group but they must submit their own work. They will also be given a one point deduction on their recitation score. The recitations will need to be submitted in Carmen by noon of the day following the recitation. At the end of the semester the lowest recitation grade will be dropped.

#### Homework

There will be six homework assignments you will need to complete in Achieve, the online homework system. These will typically be due on Tuesdays at 11:59 PM. You have unlimited attempts to complete the homework without penalty. You may get help from each other, from your instructor in office hours, or from the discussion board in Carmen. No homework grades will be dropped.

#### Quizzes

There will be six quizzes that are also in Achieve. They will typically be due on Wednesdays at 11:59 PM. There is a 90 minute time limit on the quizzes, and you only get one chance to answer each question. You may not get help on the quizzes from your classmates, the instructor, the Carmen discussion boards, or any other outside resource. At the end of the semester the lowest quiz grade will be dropped.

#### **Exams**

Exams will take place during the normal class period. They will be proctored via the same Zoom meeting as the lectures. The exact format of the exam will be announced on Carmen at a later date.

#### **Tokens**

You will each start the semester off with 4 "tokens" that can be used for the following:

- A 24-hour extension on a homework or quiz assignment.
- The ability to miss a recitation without a point deduction.
- Getting credit for a late recitation activity.

### Instructor feedback and response time

#### **Grading and feedback**

#### **Discussion and Communication Guidelines**

The following are my expectations for how we should communicate as a class. Above all, please remember to be respectful and thoughtful.

- Writing style: While there is no need to participate in class discussions as if you were writing a research paper, you should remember to write using good grammar, spelling, and punctuation. A more conversational tone is fine for non-academic topics.
- Tone and civility: Let's maintain a supportive learning community where everyone feels safe and where people can disagree amicably. Remember that sarcasm doesn't always come across online. I will provide specific guidance for discussions on controversial or personal topics.
- **Citing your sources**: When we have academic discussions, please cite your sources to back up what you say. For the textbook or other course materials, list at least the title and page numbers. For online sources, include a link.
- **Backing up your work**: Consider composing your academic posts in a word processor, where you can save your work, and then copying into the Carmen discussion.
- Synchronous sessions: During our Zoom sessions I ask you to use your real name and a clear photo of your face in your Carmen profile. During our full-group lecture time, you may turn your camera off if you choose. When in breakout rooms or other small-group discussions, having cameras and mics on as often as possible will help you get the most out of activities. You are always welcome to use the <a href="free">free</a>, Ohio State-themed virtual backgrounds (go.osu.edu/zoom-backgrounds). Remember that Zoom and the Zoom chat are our classroom space where respectful interactions are expected.

#### **Academic integrity policy**

A guiding principle is that, if you are considering doing something that might be unethical, then "Don't do it!!" This mantra applies to both academic and non-academic settings.

It is the responsibility of the Committee on Academic Misconduct to investigate or establish procedures for the investigation of all reported cases of student academic misconduct. The term "academic misconduct" includes all forms of student academic misconduct wherever committed; illustrated by, but not limited to, cases of plagiarism and dishonest practices in connection with examinations.
